TERMS OF REFERENCE FOR

REVAMP AND RE-DESIGN OF PNGEITI NATIONAL SECRETARIAT WEBSITE

1. EITI overview

The EITI is built on the notion that natural resources such as oil, gas, metals and minerals, belong to a country's citizens. The EITI's mission is to promote understanding of natural resource management, strengthen public and corporate governance and provide the data to inform greater transparency and accountability in the extractives sector.

By becoming a member of the EITI, countries commit to disclose information along the extractive industry value chain – from how extraction rights (granting of mining and petroleum licences) are awarded, to how different revenues streams make their way through to the Government and how they benefit the public.

Through participation in the EITI process, 55 countries have agreed to a common set of rulesgoverning what has to be disclosed and when – the EITI Global Best Practice Standard. EITI countries disclose extensive amount of data and information as required by the EITI Standard. The EITI Standard requires that data is made available in accessible forms to all users.

2. Project overview and phases

The PNG Extractive Industries Transparency Initiative (EITI) is looking for an experienced webdevelopment firm or an individual to carry out a substantive redesign of the PNGEITI National Secretariat site's user experience and presentation, including but not limited to; navigation and search, updated options for downloading and visualising data, visual material and graphics.

The Secretariat requires an online platform that is easy to use and navigate, and presents the PNGEITI's core themes in an engaging and visual way.

After the redesign, the Secretariat will require maintenance of the site for the year 2022. Renewal of the maintenance contract will be dependent on satisfactory performance by the web developer to be engaged.

Phases:

Phase 21 March – 03 April, 2022 Website revamp and redesign

Phase 2- March, 2022- March, 2023 Support and maintenance.

The EITI is therefore seeking bids for the following two components of the work:

Support and Maintenance of the website for 2023

The deadline for tender proposals is 11th March 2022, with an award date of 18th March, 2022. The selected web designer would ideally start this work on the 23th of March 2022 and is required to deliver on the first phase of the work by 03rd April, 2022.

3. Website objectives, tasks and expected deliverables

4. Website revamp and redesign timeline

☐ The National Secretariat will be working closely with the web developer to finalize a feasible timeline for the launch of the website. However, it is anticipated that the new website will by launched by early April 2022.

5. Qualification Requirements

Company requirements:

- The EITI is seeking an established company focused on Drupal development that has been in operation for at least three years.
- The company must have proven experience in creating and maintaining complex data portals. This should include database creation and management, managing and updating APIs, implementing platforms like CKANor DKAN for bulk download and integrating data visualisations.
- The Consultant must be a company with at least 10 full-time operational staff (such as web developers, UX designers, project managers).

 At least one key team member must be dedicated as a project manager. This person must be a highly qualified web developer with at least five years of experience from similar projects.

6. Procurement procedure

A consultant will be selected following a quality- and cost-based selecti	on
procedure. The following should be submitted:	

- ☐ A Technical Proposal which includes:
 - o Company background
 - o Key consultants assigned to the project
 - CVs and experience of each project team member including the allocation of time of each person assigned to the project
 - o Project management methodology to include the process for assigning tasks, dealing with urgent requests and estimating additional projects requested by EITI
 - o Detailed description of how the first stages of the project will be facilitated.
 - o 3-5 examples of similar projects. These should have a particular focus onworking with similar organisations with databases and APIs, data portals and modern design elements. At least one example should include direct experience in working with dynamically linked databases and APIs.
 - o An implementation timeline
- ☐ A Financial Proposal, clearly indicating:
 - o A lump sum financial proposal for the redesign,. The financial proposal should clearly differentiate fees from any other reimbursable expenses.
 - o An estimate for maintenance and 30 support hours per month of the site for 2022 based on monthly and yearly rates.
